- The sealed envelope should be submitted to the attention of the Head of Chancery, Embassy of India School, Moscow latest by 2.00 pm on 06.04.2022 accompanied with the proof of payment of Rbls. 10000/- to the Embassy of India School, Moscow vide bank transfer (Bank details can be obtained from the School Office while visiting the site for inspection). The amount of Rbls. 10000/will be treated as earnest money deposit/bid security and would be returned to all the unsuccessful bidders within 30 days after finalization of the contract with the successful supplier.
- The successful bidder shall be obliged to deposit an amount equivalent to 5% of the value of 6. the contract to be awarded as performance security. The performance security shall remain valid for a period of 60 days beyond the completion of all contractual obligations of the supplier.
